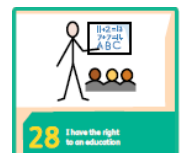

# Acceptable Use of Technology for Parents/Carer

## Parent/Carer AUP Acknowledgement.

1. I, with my child, have read and discussed Five Acre wood School learner acceptable use of technology policy (AUP) and understand that the AUP will help keep my child safe online.
2. I understand that the AUP applies to my child's use of Five Acre Wood School devices and systems on site and at home, and personal use where there are safeguarding and/or behaviour concerns.
3. I am aware that any use of Five Acre Wood School devices and systems may be monitored for safety and security reason to keep my child safe and to ensure policy compliance. This monitoring will be proportionate and will take place in accordance with data protection, privacy, and human rights legislation.
4. I am aware that the Five Acre Wood School mobile technology policy states that my child can use specific personal devices and mobile technology on site. For example communication aids.
5. I understand that my child needs a safe and appropriate place to access remote learning if Five Acre Wood School is closed in response to Covid-19. I will ensure my child's access to remote learning is appropriately supervised. When accessing video learning, I will ensure they are an appropriate location (e.g. not in bed) and that they are suitably dressed.
6. I understand that Five Acre Wood School will take every reasonable precaution, including implementing appropriate monitoring and filtering systems, to ensure my child is safe when they use Five Acre Wood School devices and systems. I understand that Five Acre Wood School cannot ultimately be held responsible for the nature and content of materials accessed on the internet or if my child is using mobile technologies.
7. I am aware of the importance of safe online behaviour and will not deliberately upload or add any images, video, sounds or text that could upset, threaten the safety of or offend any member of Five Acre Wood School community.
8. I understand that Five Acre Wood School will contact me if they have concerns about any possible breaches of the AUP or have any concerns about my child's safety.
9. I will inform the Five Acre Wood School or other relevant organisations if I have concerns over my child's or other members of Five Acre Wood School communities' safety online.
10. I know that my child will receive online safety education to help them understand the importance of safe use of technology and the internet – both in and out of Five Acre Wood School.
11. I will support Five Acre Wood School online safety approaches. I will use appropriate parental controls and will encourage my child to adopt safe use of the internet and other technology at home, as appropriate to their age and understanding.
